

**RENIHAN MEADOWS POOL RULES**  
**(distributed MAY 9, 2018 per Board of Directors)**

**POOL OPENS MAY 26, 2018**  
**POOL HOURS: 8 AM TO DUSK - WEATHER PERMITTING**

**NO LIFE GUARD ON DUTY; NO SMOKING INSIDE POOL FENCE.**  
**SWIM AT YOUR OWN RISK**  
**NO TRESPASSING AFTER POOL CLOSES**

- **No one under the age of 15 is allowed without an adult (over the age of 18 years old) present. (effective July 1, 2015)**
- **ALL POOL USERS MUST WEAR POOL PASS WRIST BAND. SECURE FROM POOL ATTENDANT, DROP REQUEST OFF AT UNIT #1 OR REQUEST TO MOSELEY@SOVER.NET. MUST PROVIDE NAME UNIT# AND AGE. Enforcement shall start for the season June 15, 2018. (PREVIOUSLY ISSUED WRIST BANDS WILL BE HONORED FOR *CURRENT RESIDENTS ONLY*)**
- **No food or drink of any kind (except “plastic” water bottles) is allowed inside the fenced pool area.**
- **Swimming suits only...no pants or shoes in the pool.**
- **Pool use is for Renihan Meadows residents and their guests only. Please limit guests to two (2) at a time and be present with your guests at the pool.**
- **One adult may not watch more than three (3) children.**
- **During inclement weather, such as lightning, thunder, or other conditions hazardous to swimmers, everyone is required to leave the pool area.**
- **Spouting of water and similar unhygienic actions will not be permitted in the pool.**
- **No diapered children in the pool unless they are wearing diapers especially designed for pool activity.**
- **No wheeled vehicles, excluding wheelchairs, are permitted in the pool area.**
- **Gate to pool must be closed at all times.**
- **Pool closes at dusk. NO TRESPASSING – VIOLATORS WILL BE FINED AND SUSPENDED.**

**These rules and regulations are for your own safety and protection. Both owners and tenants need to take responsibility for seeing that they are followed. Violators will be suspended and fined. Any damage to the pool or reported problems will mean immediate pool closure!**
